POTENTIAL CUSTOMERS ARE INSTRUCTED TO CONTACT THE ARTIST <u>DIRECTLY</u> TO SEE/DISCUSS ARTIST PRICES, AVAILABLE ARTWORK, COMMISSIONS, SHIPPING, ETC. (WATCH OUT FOR SCAMS!) THE GALLERY WILL NOT BE INVOLVED IN ANY SALE – AND THUS, THERE WILL BE NO GALLERY COMMISSION ON ANY OF YOUR SALES!!!

#### **HOW IT WORKS**

- 1. Complete agreement on the following pages and mail \$150 check to address listed.
- 2. Email images of artwork to <a href="mailto:info@GalleryofWisconsinArt.com">info@GalleryofWisconsinArt.com</a> according to following:
  - a. Photographs of Two Dimensional paintings/prints must be "flat" and cropped "square" to all 4 edges of the artwork.
  - b. Longest dimension to be 1500 pixels.
  - c. High resolution .jpg images but smaller than 2mb ea.
  - d. File name must include artist last name, and title of art, ex: HartmanWinged1.jpg
- 3. <u>Your contact info will be listed</u>. You will negotiate the sale directly with the customer including all terms, price, shipping, pickup, delivery, insurance, returns, costs, etc. No gallery commissions are charged.
- 4. No Inventory will be held by the gallery, so <u>you always retain art and coordinate</u> shipping with buyer.
- 5. <u>If you are currently on the website, but NOT interested</u> in continuing, or do not respond, all of your information will be removed from the GOWA website. *Thank you for your involvement and continued success in the future. Stay in touch!*
- 6. See agreement attached for other terms and conditions.

If you are new to the gallery, application is required. This opportunity is available to Quality, experienced artists who have a mutually respected, trusted, flexible, drama-free, and low-maintenance working relationship with the Gallery owner. If you were previously represented by the Brick and mortar gallery in West Bend, we probably still have your photo and biographical information. Contact us to discuss what we have.

- **1. WARRANTY.** You (vendor) hereby warrants that you own and/or created and possess unencumbered title to the artworks, and that the information and descriptions provided are true and accurate.
- 2. SCOPE OF AGENCY. Vendor appoints the Gallery to act as Vendor's non-exclusive agent for promotional purposes, and gallery representation only. Vendor shall be free to exhibit and sell anywhere under this agreement, including vendor's personal website. Gallery will "exhibit" work online only and will not exhibit at a physical location. Vendor's items may be represented on Gallery's website, social media, online exhibitions, gallery newsletter, and verbally by gallerist.
- **3. PROMOTIONAL CONSIGNMENT.** Vendor hereby agrees to promotes themselves to GOWA online, and Gallery promotes those artworks listed on page 5. Vendor retains copyright and full possession of the Artworks.
- **4. DURATION OF CONSIGNMENT.** Vendor and Gallery agree that the initial term of promotional representation and online consignment is for the year 2024 and 2025. Online representation may begin or end at any time that either Vendor or gallery determines. Gallery will make every effort to update online information, as promptly as possible.
- **5. PROMOTION BY GALLERY.** Gallery shall make reasonable and good faith efforts to promote artists and artwork, and undertake promotional activities on Vendor's behalf. <u>Promotion will be primarily on Gallery website</u> and *may* include social media posting, emails, eblasts, newsletters, etc. only as time and capabilities permit.
- **6. PROMOTION BY VENDOR.** At his/her own expense, Vendor is encouraged to pursue any/all promotional opportunities, including their own websites. Links to the artists page on the Gallery of Wisconsin Art website are encouraged and always welcomed.
- **7. FEES.** Fee for online listing and promotion is \$150 for 2024 through 2025. Fees are non-refundable and not prorated for any portion of any year.
- 8. COMMISSIONS. None.
- **9. PRICING.** Vendor to determine all prices for artwork. Vendor may decide if they want prices indicated on their webpage or not. The gallery will not negotiate prices with customers.
- **10. COPYRIGHT.** Online gallery shall identify Artwork with Artist's name. Vendor retains all rights to the reproduction of the Artworks except as noted in writing to the contrary. Gallery *may* (at Vendors expense) arrange to have Artworks photographed ONLY to assist consignors. Gallery is not able to prevent theft or unauthorized use of images from the website. If Vendor is concerned, it is the vendor's responsibility to provide Gallery with watermarked images and/or take other preventative measures.

<b>11. SALE.</b> Vendors handle all sales transactions directly. In addition to agreed retail price, vendor is responsible to collecting cost of artwork, all applicable sale taxes, shipping costs or arrange delivery/shipping/return policy.	or
